# Terms and Conditions of Entry

1. The promotion is open to all persons that spend over \$50.00 in a participating shop local business. Participating businesses will be listed on Cloncurry Shire Council (Council) website.
2. Local Business Network members are ineligible for the shop local draw. Family members of the Local Business Network are eligible for the shop local draw.
3. A valid entry is an entry form signed by the participating shop local store when \$50.00 or more is spent.
4. One entry per \$50 purchase with a maximum of five entries in one transaction. (e.g a shopper who spends \$250 or over will receive five entries.)
5. Multiple entries are permitted by customers during the duration of the promotion.
6. Shop owners may fill out an entry form for a shopper with their permission if unable to complete themselves.
7. It is the shoppers responsibility to:
  - a. Obtain an entry form at the time of purchase
  - b. Place it into the entry barrel at participating stores
8. Vouchers can be used at any participating shop local store. Gift cards are not transferrable for cash. All vouchers expire 12 months from the load date.
9. A person may win more than one gift card.
10. Five \$100.00 and five \$50.00 gift cards will be drawn at the Cloncurry Christmas Festival on Friday 29 November 2019.
11. Winning entries at the Christmas Festival on Monday 2 December 2019 will be removed from further draws. All other entries will remain until the final draw on Monday 16 December 2019.
12. The final draw of five \$50.00, five \$100.00, four \$500.00 and one \$1,000.00 gift cards will be drawn in the Council Office on Monday 16 December 2019 at 3.00pm.
13. The draw will run from 8.00am Monday 11 November 2019 until 12.00am Sunday 15 December 2019.
14. The winners will be notified by telephone by 10.00am on Tuesday 3 December 2019 for the first draw and 5.00pm Monday 16 December 2019 for the final draw.
15. The Cloncurry Local Business Network conducted under the Cloncurry Shire Council is the organiser of the program and may alter the terms and conditions if deemed necessary.
16. Cloncurry Shire Council reserves the right to verify the validity of entries, prize claims and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry or prize claim that is not in accordance with these terms and conditions or who tampers with the entry process. An entry that is incomplete, indecipherable, illegible or non-compliant with these terms and conditions is invalid and will not be accepted or considered.

19. A Cloncurry Local Business Network Member, Council Staff or Councillor will be present at each draw and at any time the barrel is opened.
20. Participating businesses are required to drop off entries to the Council office by 12.00pm on Monday 2 December 2019 for the first draw. Participating businesses are required to drop off entries, boxes and any remaining entry forms by 10.00am Monday 16 December 2019 for the final draw.
21. Participating businesses are those that have completed the nomination form and paid the \$25.00 entry fee.
22. Entry boxes will be located in each participating store and an entry barrel will be in the Council Office. Entry forms can be put in any of the boxes or Council barrel.
23. Participating businesses must only use the supplied entry forms. Businesses are not to photocopy forms. Please contact Council on 4742 4100 for more entry forms.
