- All lots must be clearly marked with property pegs.
- The property owner must grant Cloncurry Shire Council permission to enter the property to undertake the requested works.

Conditions specific to sewer connection applications

- Cloncurry Shire Council may enter land in order to effect any necessary alterations or repairs to the sewer connection
- Any costs including design, administration or legal costs incurred in obtaining a court order or legal entry requirements for entry onto private property to conduct the sewer works must be met by the applicant
- Where the sewer is designed to pass through private property written permission from the property owner must be obtained and forwarded to Cloncurry Shire Council before the plans will be approved or released.
